

OutperformMarket Cookie Policy

This document constitutes the cookie policy ("**Cookie Policy**") and sets out the scope, manner and general conditions for the use of cookies and other similar technologies on the Stock Trade IQ Website ("**Website**").

Precise information about the Website's functionalities, method and scope of use is contained in the Terms and Conditions and Privacy Policy, which apply with the Cookie Policy.

1. PERSONAL DATA ADMINISTRATOR

- 1.1 The Administrator of personal data is STOCKTRADEIQ sp. z o.o., with its registered office in Poznan (61-625), at the following address: Czarna Rola 30 Street, a company incorporated under the law of Poland, entered in the Register of Entrepreneurs under number 0001034119 and with tax identification number 9721339207 ("Administrator").

2. COOKIES - GENERAL INFORMATION

- 2.1 On the Website, the Administrator uses cookies or other similar technologies and tools (hereafter collectively referred to as "**cookies**").
- 2.2 Cookies are usually small text files that are sent by the Website to the end device - phone, computer, tablet - and stored there. On revisiting the Website, the cookies from your device are sent back to the Website, so that, for example, the Website is immediately displayed in your preferred language. The information collected by cookies allows us to customise services and content to individual needs and preferences of Users, as well as to compile general statistics on Users' use of the Website. A cookie usually consists of information about the website from which the cookie originates, information about the period for which it will be stored on the device, and an individual number.
- 2.3 Among the cookies, the Administrator may also use tracking pixels, these are code snippets that track Users' behaviour on the Website. The information collected is sent to the pixel administrator and on this basis, analyses are made of the Users' behaviour.
- 2.4 As part of the use of cookies, the Administrator may process data about the User's device, his/her location, activities on the Website (e.g. time of visit) and other data depending on the cookie used (e.g. interest in a selected advertisement). Cookies, as a general rule, are not personal data, but by combining them with other information, they can, to a certain extent, create personal data.
- 2.5 The Administrator ensures that the information collected through cookies is collected for the purposes specified in the Cookie Policy and is secured to protect its availability.

3. COOKIES USED ON THE WEBSITE

- 3.1 In terms of storage time, the Administrator uses "session" and "persistent" cookies. Session cookies are stored until the end of the session, i.e. closing the browser or logging out, and persistent cookies are stored according to their parameters and can be deleted manually by the User.
- 3.2 With regard to the owner, the Administrator uses its own and third-party cookies. The Website's own cookies are sent directly through the Website's domain, while third-party cookies are created by external parties.
- 3.3 The third parties referred to hereinabove are:

3.3.1 Google Ireland Limited, Google Building, Gordon House, 4 Barrow St, Dublin, D04 E5W5, Ireland, through Google Ads (advertising files for running and rating campaigns - also applicable to DoubleClick) and Google Analytics (analytical files to analyse Users' behaviour on the Website). 3.4 With regard to the purpose of their use, the Administrator uses the following cookies:

3.4.1 necessary to enable the Website to be used correctly and to ensure safe use;

3.4.2 analytical, which allow optimisation of the Website for the Administrator, through information about the use of the Website and the actions taken by the User;

3.4.3 functional, which allow information to be obtained about User preferences, including in the context of remembering chosen settings and interface preferences;

3.4.4 advertising that enable the delivery of marketing content tailored to the User.

__gads	adsense.google.com	The file, set by Google, is stored in the DoubleClick domain and tracks the number of times users view an ad, measures the success of the campaign and calculates its revenue. This cookie can only be read from the domain where it is set and does not track any data when browsing other sites.	year
__gpi	adsense.google.com	It collects information about the User's behaviour on a number of websites. This information is used to optimise the relevance of advertising on the Website.	year

4. COOKIE MANAGEMENT

- 4.1 All but the necessary cookies indicated above require the User's consent before they can be used. The User makes a choice with regard to the cookies used (exceptions remain necessary) and until explicit consent is given - acceptance and selection via a button - cookies are blocked.
- 4.2 At any time, the User can change the Website's cookie settings by withdrawing consent or objecting to cookies that are not essential.
- 4.3 The cookie settings can also be changed directly in the web browser used. At the browser level, the user can manage cookies by setting a notification each time a cookie is placed on the device or by blocking their automatic storage. Depending on the browser, the configuration can be done according to the information given below:
